### **NOTE:**

1. This Development Permit in accordance does not become effective until 15 days after the date notification of the decision on the Development Permit is publicized.
2. The Land Use By-Law provides that any person claiming to be affected by a decision of the Development Authority on a Development Permit may appeal the decision to the Subdivision and Development Appeal Board by serving written notice of appeal to the Secretary of the Subdivision and Development Appeal Board, together with reasons and appropriate fee as established by Council within 14 days after the decision of the Development Authority on a Development Permit is publicized.
3. If the development authorized by this Development Permit is not commenced within 12 months from the date of issue of the Permit and Carried out with reasonable diligence, this permit shall be null and void.

### **NOTICE OF REFUSAL**

You are further notified that you may appeal this decision to the Subdivision and Development Appeal Board in accordance with the provisions of Part Four of the Land Use Bylaw of the Village of Hughenden. Such an appeal shall be made in writing, shall include reasons for the appeal and the necessary fee as established by Council, and shall be delivered either personally or by mail so as to reach the Secretary of the Subdivision and Development Appeal Board not later than fourteen (14) days following the date of this notice. The notice of appeal shall contain a statement of the grounds of appeal.
